**TRUSTEE'S MOTION TO APPROVE COMPROMISE AND SETTLEMENT
OF COMPLAINT AGAINST CORNERSTONE CHURCH**

Samuel K. Crocker, Trustee, by and through counsel, files this Motion to Approve Compromise and Settlement of Complaint Against Cornerstone Church and states as follows:

1. Hanover Corporation, LLC, is the Debtor in this case, pursuant to the Order for Relief entered on November 15, 2006. Samuel K. Crocker is the duly appointed and acting Trustee.
2. Beginning on or about November 3, 2002, until on or about August of 2005, the Debtor made payments to the Defendant in the approximate total amount of \$176,485.40 ("Payments"). At the time of the Payments, the Debtor was insolvent and, upon information and belief, the Debtor received no consideration or value in exchange for the Payments to Cornerstone Church. The Trustee took the position that the Payments were avoidable pursuant to 11 U.S.C. §544(b), 11 U.S.C. §548(a)(1)(A), and/or 11 U.S.C. §548(a)(1)(B)
3. Accordingly, the Trustee filed a Complaint to Avoid and Recover Fraudulent Transfers against Cornerstone Church, styled *Samuel K Crocker, Trustee v. Cornerstone Church*, Adversary Proceeding Case Number 307-0311A ("Complaint").

4. Cornerstone Church, by and through counsel, filed an answer to the Complaint and a pretrial statement and raised certain issues and defenses, including whether the Debtor was insolvent and whether the transfers were exempt from recovery pursuant to 11 U.S.C. § 548(a)(2).

5. The Trustee has agreed to compromise and settle the Complaint against Cornerstone Church in consideration of the payment of \$50,000.00 from Cornerstone Church to the bankruptcy estate upon the entry of an Order Approving Compromise and Settlement.

6. It is the Trustee's opinion that the offer should be accepted in order to avoid the risk of litigation, additional attorney fees and other costs of litigation which might reduce the ultimate benefit to the estate to less than the amount received in settlement.

WHEREFORE, Trustee requests an Order approving compromise and settlement of the Complaint of fraudulent transfers with Cornerstone Church in consideration of the payment of \$50,000.00 from Cornerstone Church to the Trustee upon entry of an Order Approving Compromise and Settlement.

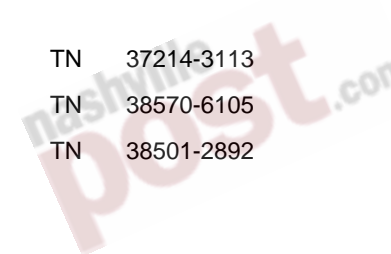
